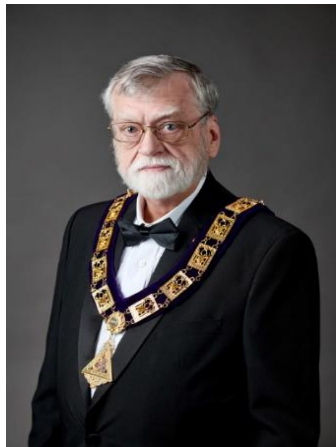

HOUSE COMMITTEE NEWS

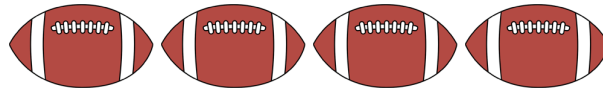
